Copy of Registration Papers, Negative Coggins less than 12 months old, PFHA card (Amateur, if applicable)

Health Certificate less than 30 days old (if out of state), PFHA Entry Forms - completed and signed

Entries must be received by midnight on 8/23/24 in order to receive the pre-entry price. After 8/23/24 the post-entry price will apply.

VET ON CALL WILL BE POSTED IN THE BARN AND IN THE SHOW OFFICE.

STALLS: To reserve stalls, text Barn Manager - Nick Burgos 484-256-4625. Stall fees cover from 12 Noon Wednesday to 12 Noon Sunday. For early arrivals, please make advance arrangements with the Barn Manager. When reserving stalls, please state approximate time of arrival if late at night or early in the morning so someone is there to help with check-in.

BEDDING: No outside bedding is to be brought into the Dream Park. 1 bag of shavings is included with your stall. You may advance order additional bedding with your stall reservations and purchase extra bedding during the show at the show office. Price is \$10 per bag.

OPPORTUNITY CLASS RULES

1. Rider cannot have shown previously in any pointed PFHA class.
2. Rider does not have to be a member of PFHA to show in the Opportunity Classes.
3. The horse must be a PFHA registered Paso Fino and the Rider does not have to own the horse.
4. Classes will be judged in accordance with the official PFHA Rule Book for each division with the exception of the riding attire as stated in Number 5.
5. Riders are not required to ride in the official PFHA Costume for the division in which they are showing. They are required to wear appropriate casual riding attire. This includes slacks or dark jeans (no shorts), chaps, a casual shirt with sleeves such as a polo shirt or dress shirt. Proper riding boots are required. For participants twelve years of age and under, a riding helmet will be required.
6. The Opportunity Class Fee will be \$15.

Federation Entry Agreement

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of The United States Equestrian Federation, Inc. (the "Federation") and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.

Federation Release, Assumption of Risk, Waiver and Indemnification. This document waives important legal rights. Read it carefully before signing.

I understand and agree that by entering this Competition, I am subject to Federation Rules, the Prize List, and local rules of the competition. I agree to waive the right to the use of my photos at the competition, and agree that any actions against the Federation must be brought in New York State.

I **AGREE** that the "Federation" and "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations.

I **AGREE** that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaultor, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").

I **AGREE** to hold harmless and release the Federation and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of the Federation or the Competition.

I **AGREE** to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Federation or the Competition.

I **AGREE** to indemnify (that is, to pay any losses, damages, or costs incurred by) the Federation and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Competition. I have read the Federation Rules about protective equipment, including GR801 and, if applicable, EV114 and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.
